### Approval of Consent Agenda

Mr. Zimmerman asked the Board whether there were any amendments or corrections to the items on the consent agenda. A motion to approve the February 11, 2020 Minutes and the Dashboard Report for February 2020, was approved unanimously.

### Finance Report

Phil Howes, Treasurer, reported that budgets will be put together over the next couple of months and the audit report is close to being complete, delayed due to new accounting standards. Budgeted contributions for current year have been revised based on a 3 month average per month.

Mr. Howes reported that the Dashboard Committee has gathered input and expects to present a prototype at the May meeting.

### Centennial Report

Dr. and Mrs. Holt gave an update on the lead gifts campaign, stating that \$5 million in lead gift commitments have been made. Dr. Holt thanked Mary McClure, David Forsee, Amy Guthrey for their leadership, Rev. Carla Aday for her conversations with members, and the Board for their faith in the committee's leadership.

Dr. Holt asked for the Board's support to enter the public phase of a \$8 million campaign, beginning with 3 gatherings the week of April 20. A motion to approve moving forward with the public phase with a goal of \$8 million capital campaign was approved unanimously.

Mrs. Holt gave an update on the progress with the history and events committees. Mr. Zimmerman thanked the Holts for their leadership.
