# **Project Overview**

### WELCOMING EAST ENTRY

Provide visible access from 61st Street and 61st Terrace.

Connect to a new outdoor plaza gathering area and to a relocated playground.





New reception center with easy access to stairwells, upgraded elevator and glass walls linking to outdoor plaza.

Reconfigured Chapel parking lot to comply with ADA requirements, and provide easy access to the new entrance, plaza and playground areas.



### SANCTUARY: Enhance and protect

Safeguard from fire by installing a sprinkler system.

Improve heating, cooling and ventilation to enhance air quality and to protect woodwork and organ and provide comfort for worship.

Upgrade audio and video systems to enhance in-person and live stream worship.



### SPIRITUAL CONNECTIONS: Parlor, Social Hall

Increase parlor area by removing walls to right and left of the Last Supper Sculpture. Cosmetic upgrades and new furnishings in Parlor and Social Hall.







### CHILDREN'S WING Expand and upgrade for safety and growth

Renovate ground floor children's wing housing Preschool, Parents' Day Out, Sunday infant and toddler care.

Add secure stairway for children's wing use only and add security doors to enter wing.

Add two classrooms, add needed bathrooms, and plumbing and finish upgrades.



### MISSION PARTNERSHIP

Partner with local agencies to construct new affordable homes for vulnerable families in Northeast Kansas City



# Impact

### WELCOMING EAST ENTRY

We often say "all means all" and that "everyone is welcome." But finding our door six days a week proves challenging. A new entryway with improved accessibility will make it easy for all first-time visitors, members, friends and guests to locate the entry and will communicate to our neighbors that they are welcome here. The outdoor plaza will create an inviting and hospitable space for conversation and a link to the multipurpose green space to be used for children, family and adult ministries.

### CHILDREN'S WING - Expand and Upgrade for Safety and Growth

The Preschool and Parents' Day Out program provides a vibrant link to the wider community and often families in the school affiliate with the congregation. For several years, we have averaged more than 24 children on a waiting list to enter the program. Adding and updating classrooms, improving security and upgrading the playground positions the church to more effectively reach out to young families and increases parent confidence in our spiritual formation ministry.





### **SANCTUARY** – Enhance and Protect

The installation of fire sprinklers will protect the majestic stained glass windows, pipe organ, and carved woodwork in our sanctuary, guarding this sacred space where each week we meet for renewing our souls and to mark the key turning points in life: marriage; baptism; memorial services. In this iconic room we are shaped by the spirit of God claiming our lives through the good news spoken and sung. Upgrades to audio and video equipment will improve both in-person worship and live streamed worship.

### **SPIRITUAL CONNECTIONS** - Parlor, Social Hall

Over a cup of coffee or a shared dinner table, we form friendships that enrich the spiritual journey. By updating these social spaces used many times each week for funeral receptions, dinners, retreats, seminars, concert receptions and a host of other church and community events, we extend God's hospitality to one another. We ensure Sunday morning guests and first-time visitors experience authentic hospitality and community. And the updates will facilitate new program development such as dinner church.

### MISSION PARTNERSHIP - \$500,000

Outreach and mission partnerships have been a cornerstone of Country Club Christian Church for 100 years. As we take care of our own spiritual home, we can also provide safe homes for others. By partnering with local agencies, we will build homes for working famlies while also offering hands-on participation in their integrated services such as financial literacy and parenting support. Across Kansas City, more than 40 percent of the population cannot afford the average cost of living and housing is a dire need in Northeast Kansas City. Owning a home is a key step for families to achieve economic security, stability for children, and new opportunities to move into self-sufficiency. We will provide more than four walls and a roof, we will offer real and lasting change for those who need it most.

# Next Phase of Our Master Plan: Re-envisioned Social Hall and Kitchen

Many have asked what's next should The Next 100 campaign donations go above and beyond our original benchmark for commitments. Early gifts have gotten us to a place where we can dream bigger: we are excited to share plans for a re-envisioned Social Hall and kitchen as the next phase of our master plan.

### NEW ENTRANCE AND RENOVATION OF SOCIAL HALL AND KITCHEN AREAS

Direct access to Social Hall from new east entrance and plaza.

Gathering space for small groups with a family-style kitchen.

Separate, new commercial kitchen.

Opening up unused areas in the Social Hall to increase space for large events.









### IMPACT

Direct/visible access to Social Hall through a new entrance infused with natural daylight.

Deepening connections through casual interactions and small meetings in an informal space.

Opportunities for groups to join together to prepare and share a meal such as Neighborhood Communion.

Increased space in Social Hall for large events such as Thanksgiving dinner.

Commercial kitchen for large events and food prep/storage supporting our mission work to feed the hungry.

# FAQs

### HOW DOES THE NEIGHBORHOOD FEEL ABOUT THE NEW EAST ENTRY?

We have shared our plans with the neighbors immediately adjacent to us and received positive feedback. We also discussed our plans at the Neighborhood Association meeting to gain their support.

### CAN WE INSTALL FIRE SPRINKLERS IN DESIGNATED PARTS OF THE BUILD-ING OR WILL CITY CODE REQUIRE IT THROUGHOUT?

We plan to sprinkle the sanctuary which is our most vulnerable space. Code allows us to sprinkle other areas as we remodel them.

### HOW MUCH PARKING WILL BE LOST AND HOW WILL THAT BE ADDRESSED?

The new east entry includes a door facing 61st St. just steps from a new drop-off area next to the street. Although we would lose about 14 parking spaces in the back of the church, new handicapped spaces will be designated at the south end of the chapel lot. These spaces will be about the same distance from the car to door as the current spaces behind the church. All the parking on the south side of the church will become handicapped parking and a camera/buzzer installed at the south door to the sanctuary will provide easy weekday access.



### ARE WE INCLUDING INFRASTRUCTURE (PLUMBING/ELECTRICAL/HEAT & AIR) UPGRADES IN THE PLAN?

Critical infrastructure upgrade costs are included in each project's budget. These costs total \$2,100,000 and cover a new rooftop chiller for air conditioning, new electrical service, new water line service and an upgraded east elevator. Each area renovated will receive needed mechanical upgrades; for example, most of the sanctuary investment is for sprinkler and air conditioning upgrades which together cost \$1,250,000.

### IS THE PRESCHOOL FINANCIALLY SELF-SUFFICIENT? WHAT WOULD BE GAINED THROUGH THE ADDITION OF NEW CLASSROOMS?

The Preschool covers its direct costs such as staff salaries and also contributes funds to the church's building services budget. Two new classrooms would allow us to serve more families to reduce the number of children currently on the waiting list.

### HOW HAVE DECISIONS BEEN MADE AND WHAT IS THE PROCESS FOR FINAL DECISIONS?

A team of lay leaders and staff have been working with an architect since the fall of 2018 to develop a Master Plan. Input from members through First Impressions meetings and a feasibility survey of members helped us adjust plans which were then costed and further refined. On March 9, the Congregational Board unanimously approved moving forward with the Centennial Benchmark of \$11 million for the gifts campaign. After the campaign is completed in mid-2021 and the money available is known, members of the Centennial Building Committee will begin to prepare for construction. Feedback from the congregation will be welcomed and the team will use it as they work with architects on final design. Then bids will be received, any needing financing arranged and a final vote made by the Congregational Board.

### WHEN WILL ACTUAL PLANS FOR THE PROJECTS AND CONSTRUCTION COSTS BE KNOWN?

The timing of construction depends on how much additional design work we need to do plus how quickly money is raised. We hope to begin construction at the end of our Centennial celebrations in the Fall of 2021 or early 2022.

### WHAT HAPPENS IF WE DON'T RAISE ENOUGH MONEY TO FUND EACH OF THE PROJECTS IN THE PLAN?

We are inspired by the positive feedback and believe our congregation has the capacity for a bold vision for the next 100 years. If we are unable to raise the money for all the projects, we can scale back the projects or consider phasing projects as money is raised.

### WILL WE TAKE OUT LOANS?

Our project plan and construction budget will ultimately mirror the pledges received in the Gifts Campaign. We may, as we have done in the past, take out a short-term line of credit during construction as pledges come in. We do not plan to take out a longer term loan unless a prudent amount is needed to complete a priority project.

### WHY ARE WE RESUMING THE GIFTS CAMPAIGN NOW RATHER THAN WAIT-ING UNTIL WE RESUME IN-PERSON WORSHIP?

While we had to limit on-campus activity over the last year, the church has stayed open through online worship and new creative ways to gather. Just as our church has continued to press forward in the face of challenges, so has our campaign with several million dollars already committed. With a vaccine becoming more available and hope swelling about gathering in-person again, the momentum towards our future only continues to grow stronger.

### WILL WE MAKE INVESTMENTS IN TECHNOLOGY GIVEN THE SUCCESS OF GATHERING VIA LIVE-STREAM?

During the pandemic, the congregational response to our high quality live-streaming greatly exceeded our initial expectations. We are investing in audiovisual systems for enhancing both live-streamed and in-person worship plus anticipate contingency dollars will accelerate our digital presence.



### WHAT WILL BE DONE TO MAKE OUR BUILDING MORE SUSTAINABLE?

We expect to employ strategies that align with current best practices in sustainable design, including:

Improve Energy Performance and Increase Ventilation – Install new heating and air conditioning system that will be at least 30 percent more efficient than the current system with potential for higher efficiencies. Design heating and air conditioning systems and building envelope to promote occupants' productivity, comfort, and well-being with greater air flow and ventilation in the building. Install triple-pane energy efficient windows in remodeled areas.

Indoor Water Use Reduction – Install water efficient toilets, urinals, private lavatory faucets, shower-heads, and appliances.

Outdoor Water Use Reduction – Incorporate native plants in landscape design to reduce irrigation needs.

Low Emitting Materials – Reduce concentrations of chemical contaminants that can damage air quality, human health, productivity, and the environment by specifying non-toxic materials.

Interior Lighting – Promote occupants' productivity, comfort, and well-being by providing high-quality and energy-efficient lighting.

Quality Views - Provide building occupants a connection to the natural outdoor environment by providing quality views.

Daylight - Connect building occupants with the outdoors and reduce the use/ need of electrical lighting by introducing daylight into the space. **Open Space** – Create exterior open space that encourages interaction with the environment, social interaction, passive recreation, and physical activities.

Heat Island Reduction – Install plants that provide shade over paving areas (including playgrounds) on the site within 10 years of planting.

These upgrades will result in improved air quality, more efficient use of electricity, and lower water consumption, which are cornerstones of sustainable design and will provide the largest impact. These strategies will be incorporated through consultation with our architect, Christopher Mitchell, Look Design, who designed and built the first building to achieve LEED Platinum certification in Kansas City, the highest sustainability rating awarded by the U.S. Green Building Council.

# **Creative Giving Strategies**

### WHAT ARE GIFTS OTHER THAN CASH?

Gifts other than cash include stocks, bonds, annuities, property, and other assets.

### WHAT KIND OF ASSETS SHOULD I GIVE?

Appreciated assets held more than one year, such as publicly traded stocks, mutual funds, bonds, real estate, collectables, and other readily marketable property often provide tax advantages.

Personal property such as automobiles, jewelry, and other items may also be given. There may be no capital gains tax benefits to these gifts, but the financial and spiritual benefits can be tremendous.

### WHY GIVE GIFTS OTHER THAN CASH?

The tax code is very generous toward this form of giving. Giving the asset directly to the church allows the church to sell the asset, thereby eliminating potential capital gains taxes to the donor. This also results in a larger gift to the church.

### HOW DOES THE TAX BENEFIT WORK?

Itemized Deduction: The donor is allowed to include 100% of the market value of many of these assets as charitable contributions for tax purposes, if held more than one year.

Because of its tax-exempt status, the church will receive the full market value, less transaction costs, at the time of sale without paying capital gains taxes.

# WHAT IF I SELL FIRST THEN GIVE THE CASH?

You may be subject to capital gains taxes thereby reducing the after-tax proceeds from the sale.

### CASH FLOW GIFTS

Smaller gifts add up! By giving smaller amounts at higher frequencies--weekly, semi-monthly, or monthly--large gifts can be reached in smaller steps. Using electronic funds transfers can be beneficial when making these gifts.

### **DIVERTED FUNDS GIFTS**

Freeing up funds that are currently going to other areas of spending allows a person to increase giving to God's work. Diverting funds from entertainment, dining out, dues, subscriptions, gifts, allowances, utilities, or transportation, offers lifestyle adjustments that impact one's giving.

### DELAYED EXPENDITURES

Postponing major expenditures such as automobiles, boats, clothing, or trips provides substantial giving opportunities.

### **INCOME PRODUCING ASSETS**

Interest income, payments from rental properties, or income from other assets provide a source for increased giving.

### SALE OF ASSETS

Sale of major assets, such as a house, car, land, or business provides available income for giving.

### **RAISES / BONUSES**

Contributing raises and bonuses is another creative method people have used to increase giving.

### FREEDOM FROM DEBT

Looking ahead to the next three years, you may discover that debt obligations will be fulfilled. This frees up revenue for additional giving.

### UNIQUE SKILLS INCOME

Some people have marketable hobbies or skills that enable them to give from those new profits.

### CORPORATE GIFTS

Business owners may be able to provide gifts-in-kind that result in significant savings to the church and may have tax benefits to the business owner.

### ESTATE GIFTS

Naming Country Club Christian Church as a beneficiary in any planned gifts such as wills, life insurance policies, retirement accounts, and others can be done through the Combs Legacy, and these gifts may be designated to the Next 100 Centennial Gifts Campaign.

### SPECIAL TAX-FREE IRA GIFTS

For those aged 70 <sup>1/2</sup> and older, it is possible to make tax-favorable charitable gifts from IRA accounts. A total of up to \$100,000 per year can be transferred directly from IRAs to one or more qualified charities. free from federal income tax. There may also be state income tax savings. For those 72 and older or those who have begun taking their Required Minimum Distribution (RMD), donations given in this way count toward RMD for the year of the gift. To donate from an IRA, it is important to make the donation directly from the IRA to the church. For those with check writing privileges on their accounts, this may be the most efficient way to make gifts directly from an IRA.
