



High School **Summer Service-Learning Week** 2021


Sunday, July 25th - Saturday, July 31st, 2021 *last updated 6/9/2021*


This summer, we are hosting service-learning weeks for youth to serve, learn, and build memories together with local service-learning opportunities and one overnight activity. Youth who complete grades 9-12 in 2021 are invited to the High School Summer Service-Learning Week from July 25 - 31st. Youth can join for the whole week or just for separate events as they are available, though participating from beginning to end is encouraged for the full experience!

This packet includes information and registration forms.

Schedule  A detailed schedule will be available three weeks before the service-learning week.

- **Sunday Kickoff:** Sunday, July 25th, 9:00am to 5:00pm
Youth are invited to our kickoff with worship, workshops, lunch, games, and a special social on Sunday.
- **Service-Learning Days:** Monday, July 26 - Thursday, July 29, 1:00pm to 7:00pm daily
From Monday through Thursday, youth will meet at the church for a service-learning day include a service project with a local partner organization and learning workshop, games, worship, and dinner at the church.
- **Overnight Excursion:** Friday, July 30, 12:00pm, until Saturday, July 31st, 10:00pm
Youth will celebrate the end of the week with an overnight trip to Branson, MO, for Silver Dollar City on Saturday. More information about this excursion TBD.

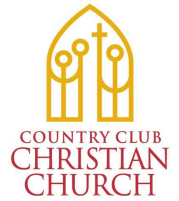
Cost  is **\$200** per youth for the full week. (\$50 due with registration, full payment due July 18)
Full cost includes supplies and donations for service projects, daily transportation to and from church, one meal a day and other snacks and refreshments, and overnight excursion to Branson (with meals from lunch on Friday to dinner on Saturday, tickets to Silver Dollar City, lodging and more), . Price can be broken down based on participation on certain days. Scholarships are available; Request information from Tyler.

To **register**,  submit a signed covenant, filled out consent & release form, and pay a \$50 deposit. Youth Covenant

As a participant in the Country Club Christian Church 2021 High School Service-Learning Week, I will...

- ...abide by the rules of our trip leaders and host organizations.*
- ...respect and abide by COVID-related safety precautions, including mask-wearing, social distancing and sanitation guidelines, per guidelines set by the CDC, Country Club Christian Church, and any places we visit during service-learning or social excursions.*
- ...act in such a way that respectfully represents oneself and the church.*
- ...especially care for and respect the property of the places we stay.*
- ...respect and follow instructions given by youth staff and adult chaperones.*
- ...be responsible of my own belongings and respect the property of others.*
- ...not bring, use, or purchase substances including (but not limited to) alcohol, tobacco (including e-cigarettes and vaporizers), and drugs. Trip leaders should be notified of any prescription drugs.*
- ...not bring, use, or purchase weapons of any kind or fireworks.*
- ...not engage in any sexual activity.*
- ...participate fully in all aspects of the trip, including team-building, fundraising, and other preparations.*
- ...be open-minded and open-hearted towards other and God during this trip.*
- ...seek to understand what it means to partner with existing work that brings hope and healing into others' lives.*

I understand that if I choose not to do these things, that I may surrender certain privileges or complete participation in this trip. I understand that my belongings are subject to search at any time while attending this trip. I understand that breaking certain parts of this covenant may require that my parents be notified and that I may be sent home at my parents' expense.

I. Permission to Participate in Activity

To whom it may concern:

II. Consent for Medical Care & Treatment

The undersigned authorizes an adult, in whose care the minor has been entrusted, to consent to any X-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care, on an emergency or non-emergency basis, to be rendered to the minor under the general or special supervision and on the advice of any licensed physician or dentist on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or at said hospital.

The undersigned shall be liable and agree(s) to pay all costs and expense incurred in connection with such medical and dental services rendered to the aforementioned child pursuant to this authorization.

Should it be necessary for our (my) child to return home due to medical reasons or otherwise, the undersigned shall assume all transportation cost.

III. Release

In consideration for being accepted by Country Club Christian Church for participation for the above-referenced trip or activity and in consideration of the value of the services rendered or to be rendered and for other good and valuable consideration, the undersigned, being 21 years of age or older, does for myself and for and on behalf of my child-participant if said child is now 21 years of age or older hereby release, forever discharge and agree to hold harmless Country Club Christian Church, its directors, officers, agents representatives, and employees thereof from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses of any nature whatsoever which may be incurred by the undersigned or the child-participant that occur while said child is participating in the above-described trip or activity, including but not limited to any claims, causes of actions, demands or liability for negligence.

Furthermore, the undersigned hereby assumes all risk of personal injury, sickness, death, damage and expense as a result of participation in the recreation and work activities involved therein.

Further, authorization and permission is hereby given to said church to furnish any necessary transportation, food and lodging for this participant. The undersigned does also hereby give permission for the child-participant to ride in any vehicle designated by the adult in whose care said child has been entrusted while attending and participating in activities sponsored by Country Club Christian Church.

The undersigned further hereby agrees to hold harmless and indemnify said church, its directors, employees and agents, for any liability sustained by said church as a result of the negligent, willful or intentional acts of the said participant, including expenses incurred attendant thereto.

Only participant need sign if 21 years of age or older. If under the age of 21, both parents must sign unless parents are legally separated or divorced in which case the custodial parent must sign.
