

High School Service-Learning Trip 2022 to Chicago

Every year, our high school youth group has a special service-learning opportunity, and we are excited this year to travel out of town to Chicago, Illinois, to serve, learn, and grow together as a youth group. On this trip, youth will create memories with their church community as they explore the transformative work of various organizations in the Chicago metro. Daily reflections will invite youth to connect their experiences to their spirituality and their faith as they ask "What is God up to?" and "How can we join in?

- Dates: Sunday, July 10, at 12:15pm, to Saturday, July 16, at 10:00pm
- **Ligible Youth:** Open to youth who finished grades 9-12 in 2022
- **\$ Estimated Cost:** \$500-600 (\$50 deposit due by 5/15, full balance due by 7/10)
 - Full cost includes lodging, meals, snacks, and all excursions.
 - Youth should bring their own spending money for snacks & souvenirs.
 - Scholarships are available if needed; request information from Tyler.
- Fundraisers: Stay tuned for fundraising opportunities this Spring.
- Meeting: We will have a meeting in May required for all participants; date & time TBA.
- Final price, lodging, service-learning projects, and excursions will be announced by March 1.

To reserve a spot, submit by <u>5/15/22</u>, submit a <u>\$50 deposit</u> along with the following <u>Covenant</u> and <u>Consent & Release Form</u> filled out and signed. The full trip balance is due by by <u>7/10/2022</u>.

Chicago Participant Covenant

High School Service-Learning Trip 2022

The 2022 High School mission trip to Chicago, Illinois, from July 10 to 16, 2022, will require that youth participants, parents, and adult leaders enter covenant with one another to respect each other and uphold certain expectations as laid out below. This covenant is more than a list of rules; it is a promise between all participants to make the most of this opportunity to serve and learn together.

Participant Covenant

As a participant on the 2022 High School Service-Learning Trip to Chicago, Illinois, with Country Club Christian Church, I promise to....

- ...abide by the rules of our trip leaders and host organizations.
- ...respect and abide by COVID-related safety precautions, including mask-wearing, social distancing and sanitation guidelines, per guidelines set by the CDC, Country Club Christian Church, and any place we visit.
- ...act in such a way that respectfully represents oneself and the church.
- ...especially care for and respect the property of the places we stay.
- ...respect and follow instructions given by youth staff and adult chaperones.
- ...be responsible of my own belongings and respect the property of others.
- ...not bring, use, or purchase substances including (but not limited to) alcohol, tobacco (including e-cigarettes and vaporizers), and drugs. Trip leaders should be notified of any prescription drugs.
- ...not bring, use, or purchase weapons of any kind or fireworks.
- ...not engage in any sexual activity.
- ...participate fully in all aspects of the trip, including team-building, fundraising, and other preparations.
- ...be open-minded and open-hearted towards others and God during this trip.

I understand that if I choose not to do these things, that I may surrender certain privileges or complete participation in this trip. I understand that my belongings are subject to search at any time while attending this trip. I understand that breaking certain parts of this covenant may require that my parents be notified and that I may be sent home at my parents' expense.

Permission to Participate in Activity To whom it may concern: The undersigned does hereby give permission for my child, (name of child:) to attend and participate in (name of trip or activity:) the High School Service-Learning Trip to Chicago, IL. Sponsored by Country Club Christian Church on (dates:) July 10, 2022, to July 16, 2022.
II. Consent for Medical Care & Treatment The undersigned authorizes an adult, in whose care the minor has been entrusted, to consent to any X-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care, on an emergency or non-emergency basis, to be rendered to the minor under the general or special supervision and on the advice of any licensed physician or dentist on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or at said hospital. The undersigned shall be liable and agree(s) to pay all costs and expense incurred in connection with such medical and dental services rendered to the aforementioned child pursuant to this authorization. Should it be necessary for our (my) child to return home due to medical reasons or otherwise, the undersigned shall assume all transportation cost.
III. Release In consideration for being accepted by Country Club Christian Church for participation for the above-referenced trip or activity and in consideration of the value of the services rendered or to be rendered and for other good and valuable consideration, the undersigned, being 21 years of age or older, does for myself and for and on behalf of my child-participant if said child is now 21 years of age or older hereby release, forever discharge and agree to hold harmless Country Club Christian Church, its directors, officers, agents representatives, and employees thereof from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses of any nature whatsoever which may be incurred by the undersigned or the child-participant that occur while said child is participating in the above-described trip or activity, including but not limited to any claims, causes of actions, demands or liability for negligence.

Furthermore, the undersigned hereby assumes all risk of personal injury, sickness, death, damage and expense as a result of participation in the recreation and work activities involved therein.

Further, authorization and permission is hereby given to said church to furnish any necessary transportation, food and lodging for this participant. The undersigned does also hereby give permission for the child-participant to ride in any vehicle designated by the adult in whose care said child has been entrusted while attending and participating in activities sponsored by Country Club Christian Church.

The undersigned further hereby agrees to hold harmless and indemnify said church, its directors, employees and agents, for any liability sustained by said church as a result of the negligent, willful or intentional acts of the said participant, including expenses incurred attendant thereto.

Only participant need sign if 21 years of age or older. If under the age of 21, both parents must sign unless parents are legally separated or divorced in which case the custodial parent must sign.
