## Welcome and Meditation

Matt Moeder, Board Chair, called the virtual meeting to order at 7:07 pm. Erin Feitz gave an opening prayer centered on the continuing effects of the pandemic on families, those who are isolated, medical and other workers, the congregation and our nation.

# **Consent** Agenda

Mr. Moeder asked the Board whether there were any amendments or corrections to the items on the consent agenda. There were none. The Board unanimously approved a motion to approve the consent agenda including the November 9, 2021 Congregational Board Minutes as amended.

# Personnel Committee Report

Mary McClure reported the Personnel Committee approved the clergy housing allowance amount for the 2022 tax year. The Board unanimously approved a motion to approve the recommended clergy housing allowance for the 2022 tax year.

# Finance Committee Report

Mr. Moeder gave an overview of the written Finance Committee report (Attachment 1). Ms. McClure updated the Board on the finance plan for the Centennial Campaign building project. Final bids and negotiation of the construction contract are lining up. The contractor is not requiring a signed loan before entering a contract, which releases some time pressure on the financing. Nevertheless, final negotiation on a construction line of credit is underway under the Finance Committee's oversight. The Board should expect to be presented with a donorguaranteed loan and the construction line of credit in the next few months.

# Centennial Campaign Update

Ms. McClure provided an update on preparations for the building project. Construction end date is planned for the middle of 2023. The latest bids are lining up to \$11M, in line with campaign pledges. Current construction decisions are the detail level. Professional designers and engineers have been involved in all stages. Feedback teams are in place for kitchen, landscaping and sustainability. Communications are coming together to support transition and changes to impact the early childhood center, congregation and staff.

In December, the Finance Committee met to review initial plans on the Centennial Building and provide recommendations on financing proposals. Amy Guthrey worked with the Centennial Campaign Committee to prepare a preliminary cash flow analysis of campaign contributions and cash payments for the construction and other components of the campaign. A detailed analysis was provided that showed the estimated maximum amount of short-term construction borrowing that would be needed to pay the bills as the campaign donations come in over the new few years. Amy helped solicit bids on the financing with several banks. These bids were reviewed by the Finance Committee with the recommendation to move forward in negotiating the loan with Enterprise Bank which is our current banking partner. As we finalize the construction timing and details as well as the financing terms, we will come back to the Board for approval to proceed with the Financing Plan and construction loan as we complete the project.

In addition, we also discussed a donor gift that will be set up as a loan to the Church but paid for and guaranteed by the donor. This is similar to the gift provided in the last campaign. We are awaiting final terms with UMB and review by our legal counsel for this loan and will come back to the Board soon for approval to proceed with the loaned supported by the gift.
